INTRODUCTION TO THE NRF

The National Research Foundation (“NRF”) is a juristic person established in terms of the National Research Foundation Act, Act 23 of 1998, and a Schedule 3A Public Entity in terms of the Public Finance Management Act.

The NRF is the government’s national agency responsible for promoting and supporting research and human capital development through funding researchers, provision of the National Research Platforms, and science outreach platforms/programs to the broader community. The NRF provides these services in all fields of science and technology, including natural science, engineering, social science, and humanities.

The NRF delivers its mandate through its internal business units which are both functional and geographical diverse. Unless specifically noted, all contracts flowing from bidding apply to all of its business units.

INTRODUCTION TO THE NRF BUSINESS UNIT RESPONSIBLE FOR THIS BID

The South African Square Kilometre Array (SKA SA) project, which includes the construction of the MeerKAT radio telescope in the Karoo, is a project of the Department of Science and Technology, executed through the National Research Foundation and SKA SA project office. Information about the project is available from www.ska.ac.za

SKA SA is constructing the MeerKAT radio telescope in the Northern Cape. The project

includes the establishment of a greenfield site (an Astronomy Reserve) near Carnarvon and the construction of the infrastructure elements required to operate radio telescopes in the reserve, including roads, power, reticulation of power and optical fibre, and links to the national optical fibre networks. MeerKAT will operate continuously during a 24-hour day and is expected to have a lifetime of about 20-30 years.

CONTEXT OF THIS PROCUREMENT

SKA SA has a number of project milestones, special events and dialogue that will need to be documented, broadcasted, published and captured. Products that we will require the service provider to deliver on will include, but not limited to: photographs, video footage, and time lapse images.

The NRF selects its appointed bidder through the following three-stage process				
<p><u>Stage 1 – Compliance to submission requirements</u></p> <p>Bidders warrant that their proposal document has, as a minimum, the specified documents required for evaluating their proposals. The NRF provides the Returnable Document Checklist listing these including which documents are mandatory (GO/NO GO) to the bidders.</p> <p>The NRF evaluates only procurement responses that are 100% acceptable in terms of the Returnable Document List. The NRF disqualifies bidders not compliant with this list for Stage 2.</p>				
<p><u>Stage 2 – Evaluation of Bids against Specifications and Quality.</u></p> <ol style="list-style-type: none"> 1. The NRF evaluates each bidder’s written response to the specifications issued in accordance to published evaluation criteria and the associated scoring set outlined in this bid invitation. The evaluation consists of the mandatory minimum specifications in a “Meet/Not meet” or “Go/No Go” format with further specifications requiring qualitative responses. 2. Where circumstances justifies it, the NRF conducts interviews with shortlisted 				

bidders for them to present further information or provide proof of functionality to the evaluation committee. In these cases, the NRF may provide the areas of concern to the short listed bidders to address in their presentations.

3. Bidders making the minimum evaluation score will pass to stage 3.

Stage 3 – Price/Preference Evaluation

The NRF compares each bidder's pricing proposal on an equal and fair comparison basis that is equitable to all bidders taking into account all aspects of the bids pricing requirements. The NRF conducts fair market-related pricing tests to arrive at an opinion of reasonableness of the bid price offered.

This bid will be awarded on rates and not a ceiling price. The average price of each bidder's hourly rate for photography, videography and time lapse will be taken to calculate the price.

The NRF ranks the qualifying bids on price and preference points claimed in the following manner:

Price - with the lowest priced Bid meeting the minimum specification as stipulated in the threshold to qualify for this stage receiving the highest price score as set out in the Preferential Procurement Policy 2017 Regulations;

Preference - preference points as claimed in the preference claim form (SBD6.1) supported by a valid BBBEE certification are added to the price ranking scores.

The NRF nominates the bidder with the highest combined score for the contract award subject to the bidder having supplied the relevant administrative documentation.

Where the fair market-related price tests reflect defective pricing or pricing outside of the fair market-related price range, the evaluators will recommend price negotiation with the winning bidder to bring the price within the fair market-related price range. Where the winning bidder did not want to participate in the price negotiation or not prepared to provide a fair market-related price, the award will be cancelled and price negotiations will commence with the second bidder in the price/preference ranking.

Bid Procedure Conditions:

Counter Conditions

The NRF draws bidders' attention that amendments to any of the Bid Conditions or setting of counter conditions by bidders will result in the invalidation of such bids.

Response Preparation Costs

The NRF is NOT liable for any costs incurred by a bidder in the process of responding to this Bid Invitation, including on-site presentations.

Cancellation Prior To Awarding

The NRF reserve the right to withdraw and cancel the Bid Invitation at any time prior to making an award and, in terms of the Preferential Procurement Policy Framework Act 2017 Regulations, where the award price is outside of the objective determined fair market-related price range, will cancel the award.

Collusion, Fraud And Corruption

Any effort by Bidder/s to influence evaluation, comparisons, or award decisions in any manner will result in the rejection and disqualification of the bidder concerned.

Fronting

The NRF, in ensuring that bidders conduct themselves in an honest manner will, as part of the bid evaluation processes where applicable, conduct or initiate the necessary enquiries/investigations to determine the accuracy of the representation made in the bid documents. Should any of the fronting indicators as contained in the “Guidelines on complex Structures and Transactions and Fronting”, issued by the Department of Trade and Industry, be established during such inquiry/investigation, the onus will be on the bidder to prove that fronting does not exist. CONTRACT PERIOD

The contract is for a period of 3 years. The contract period commences from the date that both parties sign the contract (SBD7 contract signature page)

SCOPE OF WORK

To appoint a panel of up to 4 service providers for a period of 3 years who, once awarded will work on a rotational basis whenever the required need arises. Specifications can be found below:-

Photographs

These will range from portrait images of individuals to industrial photographs of various technologies / items / products (as example the construction on site in Carnarvon) to 180 degree semi-hemispheric images for digital planetariums and 360 degree panoramic images, as well as panoramas. Photographs will need to be done using the most recent, innovative and creative photography techniques in order to present the various products, stages of construction, and business of the SKA South Africa in a captivating manner. These images should be able to reflect the world-class research and facility that is true for SKA South Africa. Photographs should be presented in TIFF and RAW format for large graphic printing, as well as JPEG or PNG that will allow for web-based publishing, with the option for inclusion in all print and broadcast (television / digital video / analogue, etc.).

The candidate service provider will need to show evidence, by presenting a portfolio of their ability and experience in using various techniques in order to capture images on film and how / where these were used. The bidder's footage and photos must be submitted in Low and high resolutions (of various requirements) will need to be made available of each image in order to facilitate the sharing of this information.

Video footage

The business of SKA South Africa requires that we often have to share information and conduct dialogue sessions that link our offices across our three sites and our partner organisations from across the globe. For this reason, for special events / strategic dialogue sessions, etc., we are required to provide high quality video images that allow for the optimal level of engagement through these internet-based meetings. The service provider will therefore need to demonstrate their capability to provide the service at these special web-based events / meetings to film proceedings from the relevant sites of the SKA South Africa branches so that it can be broadcasted through the internet in order to link up with audio/visual, video conferencing facilities across the globe. (See <http://www.tenet.ac.za/vidyo/videoconferencing-with-vidyo> for details).

Outside of this specific technical requirement, we will also require the filming of key events, public talks, etc. on video in the formats and of the quality that would allow for broadcast on various platforms (online, digital, analogue, television, etc.). Low and 4K resolutions / definition video footage (of various requirements) will need to be made available of each recording in order to facilitate the sharing of this information.

On completion of the capturing of the video footage, an AV production of between 3-5 mins needs to be provided, when requested.

The successful service provider needs to ensure that virtual reality videography is captured, and post production completed and needs to be submitted in a format which is ready for display and can be viewed using a google box or VR headset.

Time Lapse Images

To capture time lapse images of the construction and erection of MeerKat antenna as well as any further construction or for the purpose of updating stock.

To ensure that all equipment on site will be tested for Radio Frequency Interference (RFI).

To capture relevant cutaways. To ensure that images captured are available in High and Low resolution. To create an edited time lapsed image AV clip of the entire core site, with cutaways, of the assembly of the various antennas on a monthly basis. Every three months, the footage collected needs to be edited and condensed to produce a 5 minute clip.

National representation

SKA South Africa requires that the candidate service provider demonstrates their ability to provide the service of delivering on the required products by having a technical crew available in both the Western Cape and Gauteng Provinces. If the candidate service provider will be demonstrating this through a process of subcontracting, then a detailed list of all intended sub-contracting companies or individuals will need to be included in the proposal.

It is essential for SKA South Africa that the products are not reflective of a single artistic approach or technique but uses a variety of techniques in order to deliver on the required products. It is therefore essential that the candidate service provider demonstrates their ability to include a number of skilled and artistic professionals on their team. The candidate service provider will be required to demonstrate this by including a portfolio of their team members with a brief profile of each.

It may be required that the actual products are used to portray the information required. It is therefore essential that the candidate service provider demonstrates their ability to communicate key messages, provide a narrative through the delivery of the required products. This can be done by including a specific focus in the portfolio that demonstrates

'journalist photography', 'exhibit photography', etc.

Development interventions

SKA South Africa will require that the successful bidders to assist in developing the community members from the SKA Karoo operational area, in their ability to document through film and photography, of the developments of SKA South Africa. Candidate service providers will therefore need to demonstrate their ability to train individuals on the techniques of film and photography. This will need to be supplemented by running two separate photography and film competitions during the period of appointment in order to select prize winners and profile these associated products. It will be the requirement of the candidate service provider to include a proposal of implementing these competitions as part of their overall submission in response to this Call for Proposals.

The cost of issuing prizes will be determined by SKA South Africa; however, all other related costs will need to be budgeted for in the proposal. SKA SA will manage the selection process of the candidates to be trained. The aim of this exercise is to train the individuals on the principles of basic photography and videography in order for them to conduct community related projects.

Cataloguing, filing and submission

All products need to be submitted to SKA South Africa in digital format. All the relevant images need to be completed with the necessary metadata, and sent in a version which is archived. The associated courier costs / data download costs will be covered by SKA South Africa. All data upload costs will need to be covered by the successful bidder.

Within 36 hours following the conclusion of a commissioned assignment, the successful bidder needs to provide access to the required products. These products will need to be filed appropriately and each product labelled with a caption that includes the necessary information. All Products and processed images must include the following metadata in the XMP format (header and structure will be provided by the SKA office):

- Location where product was captured – by way of GPS coordinates;
- Names of all individuals included in the images / captured on film – full names and titles;
- Names of instruments, objects that are captured.
- Name of Location where the image was taken
- Name of event.
- List of instruments in the image / capture on video
- Name of objects in the image
- Full names and titles of individuals captured in the image/ on video
- Photographer Name
- Photographer email address

Given the requirement that the successful bidder will need representation in the Western

Cape and Gauteng Provinces, no travel costs for assignments commissioned in these provinces will be covered by SKA South Africa. SKA South Africa will however, cover the associated costs of traveling a team of no more than two persons to a specific venue outside of these provinces when commissioning an assignment. SKA South Africa will therefore be covering the travel related costs i.e. flights, excess baggage, car hire, petrol allowance and accommodation of visits to the site in Carnarvon for no more than two persons upon discussing the assignment costs associated with the commissioned work.

This Standard Bidding Document (SBD) must form part of all bids invited. It contains general information and serves as a declaration form for local content (local production and local content are used interchangeably).

Before completing this declaration, bidders must study the General Conditions, Definitions, Directives applicable in respect of Local Content as prescribed in the Preferential Procurement Regulations, 2017, the South African Bureau of Standards (SABS) approved technical specification number SATS 1286:2011 (Edition 1) and the Guidance on the Calculation of Local Content together with the Local Content Declaration Templates [Annex C (Local Content Declaration: Summary Schedule), D (Imported Content Declaration: Supporting Schedule to Annex C) and E (Local Content Declaration: Supporting Schedule to Annex C)].
