INTRODUCTION TO THE NRF

The National Research Foundation (“NRF”) is a juristic person established in terms of the National Research Foundation Act, Act 23 of 1998, and a Schedule 3A Public Entity in terms of the Public Finance Management Act.

The NRF is the government’s national agency responsible for promoting and supporting research and human capital development through funding researchers, provision of the National Research Platforms, and science outreach platforms/programs to the broader community. The NRF provides these services in all fields of science and technology, including natural science, engineering, social science, and humanities.

The NRF delivers its mandate through its internal business units which are both functional and geographically diverse. Unless specifically noted, all contracts flowing from bidding apply to all of its business units.

INTRODUCTION TO THE NRF BUSINESS UNIT RESPONSIBLE FOR THIS BID

The business unit SKA SA is a multi-disciplinary research facility for research in the field of radio astronomy with its primary function is focused on construction of radio telescopes in the Karoo and promoting its research fields in southern Africa.

The SKA SA Losberg site in the Karoo is host to the Square Kilometre Array, MeerKAT, and KAT-7 radio telescope installations, as well as the HERA experiment.

Additionally, the site hosts a number of guest instruments from other institutions, including the PAPER experiment, which was in operation from 2009 – 2015. This consisted of 128 low frequency dipole antennas housed in ground-based trough reflectors.

SKA SA is currently constructing the low frequency Hydrogen Epoch of Reionization Array (HERA) on the pre-existing PAPER site, which will consist of up to 350 14m dishes, constructed from low-cost building materials. The PAPER and HERA experiments are both project managed out of the University of California at Berkeley, with partner institutions across the United States, the UK, Italy, and South Africa. 37 antennas have been constructed as part of precursor build programmes. An array of 240 antennas is expected to be in operation by the end of 2018.

The location of HERA on the SKA SA Karoo site is located at 30°43'15"S, 21°25'40"E (GPS coordinates).

CONTEXT OF THIS PROCUREMENT

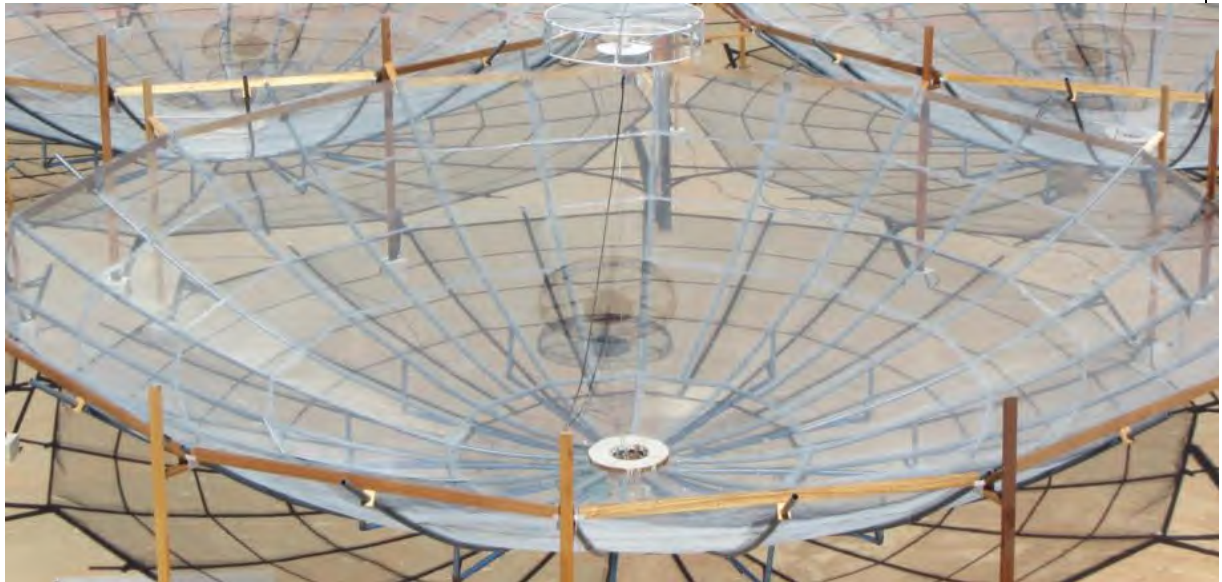


Figure 1: One of the HERA prototype dishes

The reflector support structure for the HERA dishes is made up of PVC pressure pipe cut to various specifications – these form the ‘shape’ of the dish and can be seen as blue radial spars in Figure 1. The specifications contained herein have been qualified during the precursor build phases.

The buildout of the antennas which make up the HERA experiment is due to increase at a rapid rate in 2017. To ensure consistency of construction material supply, this supply tender requests the supply, manufacture, and delivery of various PVC parts fabricated according to the specifications detailed in this document and delivered to the SKA SA Losberg site in 4 nominally equal staged quantities.

THE BIDDING PROCESS

This bid is evaluated through a three-stage process

Stage 1 – Compliance to Requirements including Mandatory as these are GO/NO GO gates

Bidders warrant that their proposal document has, as a minimum, the specified documents required for evaluating their proposals. The NRF provides the Returnable Document Checklist listing these including which documents are mandatory (GO/NO GO) to the bidders.

The NRF evaluates only procurement responses that are 100% acceptable in terms of the Returnable Document List. The NRF disqualifies bidders not compliant with this list for Stage 2.

Stage 2 – Evaluation of Bids against Specifications and Quality.

The NRF evaluates each bidder’s written response to the specifications issued in accordance to published evaluation criteria and the associated scoring set outlined in this bid invitation.

The NRF will, where circumstances justifies it, request an evaluation sessions such as interviews/presentations/pitching sessions/proof of functionality sessions with the bidders before concluding the evaluation stage.

Bidders making the minimum evaluation score will pass to stage 3.

Stage 3 – Price/Preference Evaluation

The NRF compares each bidder’s pricing proposal on an equal and fair comparison basis that is equitable to all bidders taking into account all aspects of the bids pricing requirements. The NRF ranks the qualifying bids on price and preference points claimed in the following manner:

Price - with the lowest priced Bid meeting the minimum specification as stipulated in the threshold to qualify for this stage receiving the highest price score as set out in the Preferential Procurement Policy 2011 Regulations;

Preference - preference points as claimed in the preference claim form (SBD6.1) supported by a valid BBBEE certification are added to the price ranking scores.

The NRF nominates the bidder with the highest combined score for the contract award subject to the bidder having supplied the relevant administrative documentation.

Bid Procedure Conditions:

Counter Conditions

The NRF draws bidders' attention that amendments to any of the Bid Conditions or setting of counter conditions by bidders will result in the invalidation of such bids.

Response Preparation Costs

The NRF is NOT liable for any costs incurred by a bidder in the process of responding to this Bid Invitation, including on-site presentations.

Cancellation Prior To Awarding

The NRF reserve the right to withdraw and cancel the Bid Invitation at any time prior to making an award.

Collusion, Fraud And Corruption

Any effort by Bidder/s to influence evaluation, comparisons, or award decisions in any manner will result in the rejection and disqualification of the bidder concerned.

Fronting

The NRF, in ensuring that bidders conduct themselves in an honest manner will, as part of the bid evaluation processes where applicable, conduct or initiate the necessary enquiries/investigations to determine the accuracy of the representation made in the bid documents. Should any of the fronting indicators as contained in the "Guidelines on complex Structures and Transactions and Fronting", issued by the Department of Trade and Industry, be established during such inquiry/investigation, the onus will be on the bidder to prove that fronting does not exist.
