The NRF compares each bidder’s pricing proposal on a fair and equal basis taking into account all aspects of the bids requirements. The NRF ranks the qualifying bids on price and preference points claimed in the following manner:

**Price** - with the lowest priced Bid on an equal and fair comparison basis receiving the highest price score as set out in the Preferential Procurement Policy 2011 Regulations;

**Preference** - preference points as claimed in the preference claim form (SBD6.1) added to the price ranking scores; and

The NRF nominates the bidder with the highest combined score for the contract award subject to the bidder having supplied the relevant administrative documentation.

**Bid Procedure Conditions:**

**Counter Conditions**

The NRF draws bidders’ attention that amendments to any of the Bid Conditions or setting of counter conditions by bidders will result in the invalidation of such bids.

**Response Preparation Costs**

The NRF is NOT liable for any costs incurred by a bidder in the process of responding to this Bid Invitation, including on-site presentations.

**Cancellation Prior To Awarding**

The NRF reserve the right to withdraw and cancel the Bid Invitation at any time prior to the delegated authoriser making an award.

**Collusion, Fraud And Corruption**

Any effort by Bidder/s to influence evaluation, comparisons, or award decisions in any manner will result in the rejection and disqualification of the bidder concerned.

**Fronting**

The NRF, in ensuring that bidders conduct themselves in an honest manner will, as part of the bid evaluation processes where applicable, conduct or initiate the necessary enquiries/investigations to determine the accuracy of the representation made in the bid documents. Should any of the fronting indicators as contained in the “Guidelines on complex Structures and Transactions and Fronting”, issued by the Department of Trade and Industry, be established during such inquiry/investigation, the onus will be on the bidder to prove that fronting does not exist. ## INTRODUCTION TO THE NRF

The National Research Foundation (“NRF”) is a juristic person established in terms of the National Research Foundation Act, Act 23 of 1998, and a Schedule 3A Public Entity in terms of the Public Finance Management Act.

The NRF is the government’s national agency responsible for promoting and supporting research and human capital development through funding researchers, provision of the National Research Platforms, and science outreach platforms/programs to the broader community. The NRF provides these services in all fields of science and technology, including natural science, engineering, social science, and humanities.

The NRF delivers its mandate through its internal business units which are both functional and geographical diverse. Unless specifically noted, all contracts flowing from bidding apply to all of its business units.

## INTRODUCTION TO THE NRF

The NZG is a wildlife biodiversity conservation and research organisation that has a unique distinction of incorporating a living animal collection, a biomaterials bank and an annual visitorship of 600 000. Together these features give the NZG its status, and a unique character, as a national facility that (i) generates knowledge for conservation of wildlife; (ii) develops high quality human resources in the form of conservation scientists and biodiversity conservation practitioners; (iii) undertakes *ex-situ* conservation of wildlife and makes qualified contributions to *in-situ* conservation of threatened species and their habitats;

(iv) serves as a science advancement platform: a place of learning and a source of inspiration to action for science and biodiversity; (v) enhances the quality of life of the community by providing a top class metropolitan ecotourism facility, a family attraction of first choice that inspires discovery, appreciation, care, knowledge and respect for nature.

The NZG's Research & Scientific Services Department contributes to scientific research through prioritized, funded, completed, disseminated and applicable (policy and management decisions) knowledge to understand biological diversity. The two driving vehicles are the Centre for Conservation Science and the Centre for Wildlife Health with the NZG Biobank. The CfCS is well placed within the conservation community to develop new and improved technologies and offer research-orientated services and quality, efficient and professional research expertise to other zoological gardens, academic institutions, conservation agencies and organizations. The CfCS has dedicated laboratories and encompasses three buildings for bioinformatics training, wildlife forensics and conservation genetics services and research. The genetics laboratories host a variety of equipment facilitating DNA and RNA extraction, PCR as well as two genetic analysers used for sequencing and microsatellites.

## **CONTEXT**

The NZG is in the process of acquiring Next Generation Sequencing (NGS) technology. As part of the platform there is a requirement for downstream analysis of the NGS data through the implementation of real-time PCR (RT-PCR) that is capable of performing SNP genotyping for non-model organisms. At the NZG, this technology would be used by all members of the platform as well as associated students. In addition to forming part of the NGS platform workflow, the machine can also be implemented as a stand-alone tool for additional research (such as protein analysis, high resolution melt, copy number variation, and pathogen detection) and as such represents an opportunity for the organization to maximize throughput at decreased cost.

## **CONTRACT PERIOD**

The purchase of the real-time PCR instrument and warranties is once off. A 10 year contract for the supply of chemicals and consumables and a five year maintenance plan is included.

## **SPECIFICATIONS FOR THE REQUIRED PROCUREMENT**

### **GOODS REQUIRED**

- a. The high throughput real-time PCR system must be scalable and flexible according to research needs.
  - a. System must be flexible to support 96 or 384 well plates
  - b. System as a minimum must be able to be used across a broad range of applications, including gene expression, SNP genotyping (screen between 20 to 180 SNPs in a single run), protein analysis, high resolution melt, copy number variation, and pathogen detection.
  - c. System must be flexible in terms of multiplexing
  - d. System must include a minimum of six independent excitation and emission filter channels with dual-color detection
- b. The instrument must be able to genotype custom SNPs designed for non-model species based on data provided by the NZG.
  - a. Support services must be available for the development of custom genotyping plates
- c. Instrument must be pre-calibrated with at least 11 dyes including the following during installation at NZG: FAM, VIC, ROX, ROI, SYBR, LIZ, JOE, TET, HEX, NED, TAMRA or equivalent.
- d. System must be standardised with two homogeneous reaction chemistries including SYBR green and dual colour Taqman or equivalent.
- e. The instrument must include auxiliary equipment required for automated sample loading.
- f. The instrument must include comprehensive software analysis tools for gene expression, and genotyping.
- g. Adequate training by trained engineers and/or specialists using one complete run should be provided by the supplier to 10 NZG staff members.
  - a. The CV of trained engineer and/or specialist, clearly mentioning their experience of working with the supplier and handling a similar training in the past, should be provided with the proposal.
  - b. All necessary kits, reagents and other consumables needed for both the trainings will be provided by the supplier at no extra cost.
- h. The supplier must supply one uninterruptible power supply (UPS) with sufficient capacity for at least one hour battery backup and standard surge protection along with the system.
- i. Future upgrades, for a period of five years in the instrument chemistry should be provided at no extra cost.
