## THE BIDDING PROCESS

### This bid is evaluated through a three stage process

#### Stage 1 – Compliance to Requirements including Mandatory as these are GO/NO GO gates

Bidders warrant that their proposal document has, as a minimum, the specified documents required for evaluating their proposals. The NRF provides the Returnable Document Checklist listing these and which documents are GO/NO GO at the end of this invitation for the bidders.

**The NRF evaluates only procurement responses that are 100% acceptable in terms of the Returnable Document List. The NRF disqualifies bidders not compliant with this list for Stage 2.**

#### Stage 2 – Evaluation of Bids against Specifications and Quality

The NRF evaluates each bidder's response to the specifications issued in accordance to published evaluation criteria and the associated scoring set outlined in this bid invitation.

The NRF will, where circumstances justifies it, request an evaluation sessions such as interviews/presentations/pitching sessions/proof of functionality sessions with short-listed bidders before concluding the evaluation.

Bidders making the minimum evaluation score will pass to stage 3.

#### Stage 3 – Price/Preference Evaluation

The NRF compares each bidder's pricing proposal on a fair and equal basis taking into account all aspects of the bids requirements. The NRF ranks the qualifying bids on price and preference points claimed in the following manner:

**Price** - with the lowest priced Bid on an equal and fair comparison basis receiving the highest price score as set out in the Preferential Procurement Policy 2011 Regulations;

**Preference** - preference points as claimed in the preference claim form (SBD6.1) added to the price ranking scores; and

The NRF nominates the bidder with the highest combined score for the contract award subject to the bidder having supplied the relevant administrative documentation.

### Bid Procedure Conditions:

#### Counter Conditions

The NRF draws bidders' attention that amendments to any of the Bid Conditions or setting of counter conditions by bidders will result in the invalidation of such bids.

#### Response Preparation Costs

The NRF is NOT liable for any costs incurred by a bidder in the process of responding to this Bid Invitation, including on-site presentations.

**Cancellation Prior To Awarding**

The NRF reserve the right to withdraw and cancel the Bid Invitation at any time prior to the delegated authoriser making an award.

**Collusion, Fraud And Corruption**

Any effort by Bidder/s to influence evaluation, comparisons, or award decisions in any manner will result in the rejection and disqualification of the bidder concerned.

**Fronting**

The NRF, in ensuring that bidders conduct themselves in an honest manner will, as part of the bid evaluation processes where applicable, conduct or initiate the necessary enquiries/investigations to determine the accuracy of the representation made in the bid documents. Should any of the fronting indicators as contained in the "Guidelines on complex Structures and Transactions and Fronting", issued by the Department of Trade and Industry, be established during such inquiry/investigation, the onus will be on the bidder to prove that fronting does not exist. ## **1. INTRODUCTION TO THE NRF**

The National Research Foundation ("NRF") is a juristic person established in terms of the National Research Foundation Act, Act 23 of 1998, and a Schedule 3A Public Entity in terms of the Public Finance Management Act.

The NRF is the government's national agency responsible for promoting and supporting research and human capital development through funding researchers, provision of the National Research Platforms, and science outreach platforms/programs to the broader community. The NRF provides these services in all fields of science and technology, including natural science, engineering, social science, and humanities.

The NRF delivers its mandate through its internal business units which are both functional and geographical diverse. Unless specifically noted, all contracts flowing from bidding apply to all of its business units.

## **2. INTRODUCTION TO THE NRF BUSINESS UNIT RESPONSIBLE FOR THIS BID**

The South African Agency for Science and Technology Advancement (SAASTA) is a business unit of the National Research Foundation. SAASTA's mission is to promote broad public awareness, appreciation and understanding of science, engineering and technology in South Africa.

The facility is located At 25°45'3.70" S, 28°11'21.35" E (GPS coordinates).

### 3. BACKGROUND TO PROGRAMME (DST PROGRAMMATIC SUPPORT GRANT INTERVENTION)

An agreement was signed between the Department of Science and Technology (DST) and NRF|SAASTA to coordinate the programmatic support funding as required by the DST's mandate for developmental support of science centres. The agreement provides the necessary guidelines in the implementation of the DST science centre developmental support over the period of 2016/17 and 2017/18.

A science centre

- Is a permanently established science engagement facility addressing the four aims of the science engagement strategy; Viz:
  - popularising science, engineering, technology and innovation as attractive, relevant and accessible in order to enhance scientific literacy and awaken interest in relevant careers;
  - developing a critical public that actively engages and participates in the national debates on science and technology to the benefit of society;
  - enhancing science engagement through science communication activities; and
  - profiling South African science and science achievements, demonstrating their contribution to national and international development.
- has functional interactive science exhibitions;
- run informal educational experiences through the use of interactive STEM exhibits, displays and programmes;
- has permanently qualified employed employee(s);
- has an annual plan for its activities;
- has a financial management system in place and
- has been visited by DST and SAASTA for verification.

In the context of this document, science centres are classified as either science centres belonging to the national network of science centres **or** emerging science centres. The national network of science centres refers to centres that are aligned to and supported by the Department of Science and Technology. The list of current funded science centres is provided under this section of these terms of reference. On the other hand, emerging science centres are defined as per definition of science centres above offering similar programmes as those of science centres belonging to the national network of science centres.

Voluntary networks that do not fit the above definition shall not qualify for this funding.

The following is a list of science centres that has been visited by DST and SAASTA for verification. These science centres are **currently funded** in the network, including the local chapter of the South African Association of Science and Technology Centres (SAASTEC)

#### SCOPE/SUMMARY OF SUPPLY

The overall aim of the Programmatic Support Intervention (PSI) is to contribute to an environment that enables science centres to respond to the following **objectives** of the national network of science centres:

- a. Promotion of science and technology literacy among youth and the general public;
- b. Enhancement of learner participation and performance in science, technology, engineering and mathematics (STEM);
- c. Promotion of STEM career education;
- d. Identification and nurturing of youth talent and potential in STEM.

In responding to the objectives of the network of science centres, science centres must conduct activities that will address the following aims of the Science Engagement Framework:

- a. popularising science, engineering, technology and innovation as attractive, relevant and accessible in order to enhance scientific literacy and awaken interest in relevant careers;
- b. developing a critical public that actively engages and participates in the national debates on science and technology to the benefit of society;
- c. enhancing science engagement through science communication activities; and
- d. profiling South African science and science achievements, demonstrating their contribution to national and international development.

SAASTA is inviting science centres through a call to submit innovative and creative proposals for programmatic funding for the 2016/2017 fiscal year and extended to 2017 calendar year.



#### 4. CONTEXT

The objective is to allow both emerging science centres and existing members of the national network of science centres (as listed in section 2) to apply for funding meant to support science centre awareness, development and engagement activities. Please note that there are different evaluation criteria for science centres that are members of the national network of science centres (Section 8.1) and emerging science centres (Section 8.2). The funding excludes construction of buildings.
