iThemba LABS (Laboratory for Accelerator-Based Sciences) is a multi-disciplinary research laboratory based at two sites, in the Western Cape and Gauteng respectively, these provide facilities for:

- Basic and Applied Nuclear Physics Research using Particle Beams
- Research Radiation Biophysics
- The supply of Accelerator-produced Radioactive Isotopes for Nuclear Medicine and Research

## CONTEXT OF THIS PROCUREMENT NEED

The primary objective in a system of radiation protection is to regulate personnel occupational exposure, to ensure compliance with legal requirements and maintenance of exposures to personnel, the environment and the public within legal limits in accordance to the “as low as reasonably achievable” (ALARA) principle. In the context of iThemba LABS the following sources of ionizing radiation may be encountered:

- Photons (X- and  $\gamma$ -rays) ranging from tens of eV up to several MeV
- Electrons and positrons ( $\beta^+$  and  $\beta^-$ ) in the keV and MeV range
- Neutrons up to an energy of 200 MeV
- Alpha particles typically in the MeV range
- Protons and other ions up to a maximum energy of 200 MeV per nucleon (exposure condition interlocked)

Radiation Safety, Health, Environmental and Quality (RSHEQ) Department of NRF/iThemba LABS is committed to:

- The Health and Safety of all students, employees, visitors and to the protection of the Environment.
- The protection of all students, employees and visitors against exposure to harmful effects of ionising radiation.
- Contributing towards sustainable development by optimizing resources in a safe and healthy Environment.
- Educate, train and motivate iThemba LABS employees to be responsible custodians of all RSHEQ matters.
- Comply with all relevant Safety, Health and Environmental legislation and other corporate requirements such as standards, directives, policies, procedures and guidelines.
- Comply with all rules, regulations and codes of practice mandated by the regulatory authority such as the South African Health Product Regulatory Authority (SAHPRA) and the Department of Energy.

To comply with national regulatory requirements and best international practices iThemba LABS is committed to personnel and environmental radiation dose monitoring thus requiring the service provider to issue a dosimetry standard aligned with the National Dose Register requirements i.e. (Thermo-Luminescence Dosimeters (TLD) or Optically Stimulated Luminescence (OSL) Dosimeters) to measure, record and report results of occupational (personnel) dose equivalent Hp0.07 and Hp10 for X-rays, gamma rays, beta and neutron radiation exposure as well as environmental dose equivalent (passively) for X-rays and gamma radiation.

# PART A – CONTRACT

## SCOPE OF WORKS

Radiation Workers at NRF/iThemba LABS are issued with Radiation Dosimeters to record their occupational exposure to various sources of ionizing radiation in the workplace. Dosimeters are to be provided on a 28-day cycle as required by the applicable regulation. Environmental dosimeters are issued on a quarterly basis to monitor radiation exposure passively across the site. According to SAHPRA document on Guidelines regarding organisational requirements for authority holders and their appointed radiation protection officers in respect of Group iv hazardous substances (Hazardous Substances Act, 1973 (Act 15 of 1973))

Section 2.1.2: “All radiation workers must be issued with personal dosimeters, obtainable from a Radiation Protection Dosimetry Service Provider”. This request is to comply with national regulatory requirements and best international practices. Results from this service assist in monitoring dose accumulated yearly for each radiation worker so as not to exceed administrative dose limit set by NRF/iThemba LABS and also National and International dose limits set by the various regulatory bodies.

NRF/iThemba LABS seeks to appoint a Radiation Protection Dosimetry Service provider registered with the South African National Dose Registry (NDR), the National Nuclear Regulator (NNR) to provide the following service:

1. Provide occupational dosimetry service for measuring, recording and reporting results of personnel dose equivalent Hp0.07 and Hp10 i.e. skin and deep dose for X-rays, gamma rays, beta and neutron radiation using Thermo luminescence or Optically stimulated luminescence (OSL) dosimeters.
2. Provide dosimetry service for measuring environmental dose equivalent for x-rays and gamma rays using environmental Dosimeters (Thermo luminescent (TLD) or Optically stimulated luminescence (OSL)).
3. Supply personnel dose records to the National Dose Register, as required by the regulator (NNR), register or deregister workers as radiation workers on instruction of the iThemba LABS and supply individual dose reports obtained from the National Dose Registry on request of the iThemba LABS
4. The appointed bidder shall notify iThemba LABS to collect dosimeters when these are ready for collection in each relevant wearing period.
5. The appointed bidder shall prepare dosimeters for collection by courier i.e. pack dosimeters (damage proof), measure and weigh package and supply iThemba LABS with package information to arrange collection with courier service. Upon collection the appointed service provider shall fill in required waybill information as instructed by iThemba LABS.
6. The appointed service provider shall email electronic copies of dose results for each wearing period as well as the invoice. E.G. CSV files.

- 1.6. Bidders Disclosure (SBD 4). (Refer to page 31)
- 1.7. Preference points claim (SBD 6.1). (Refer to page 34)
- 1.8. CV of staff/operators

## CONTRACT PERIOD

5-years, radiation protection dosimetry service contract.

## SPECIAL CONDITIONS OF CONTRACT MANAGEMENT

(Special conditions amending specific clauses of the general conditions of contract reference the specific clause in the title).

### Performance Verification

The iThemba LABS, RSHEQ department verifies the performance of this contract with reference to the required requirements and any other element specified in this contract:

1. The appointed bidder supplies Environmental and Personnel Thermo-luminescence Dosimeters (TLD) or Optically stimulated luminescence (OSL) Dosimeters (measuring, recording and reporting results on dose equivalent for x-rays, gamma rays, beta and neutron radiation to the iThemba LABS RSHEQ personnel).
2. iThemba LABS personnel verify the results of dosimetry service against the specifications.
3. The appointed bidder manages all project activities and processes in accordance with accepted industry practice and in consultation with iThemba LABS personnel
4. The appointed bidder will make available and collect dosimeters at a mutually agreed on location for third party collection and drop-off as defined in SLA
5. Both parties agree on quantity, unit cost, and total value on the same signed document.

**Contract Due Diligence during the contract period**

iThemba LABS has the right to conduct supply chain due diligence at any given time during the contract period.

**Inspections, tests, and analyses (General Condition of Contract Clause No: 8)**

The appointed bidder to ensure all dosimeters (TLD/OSL) used are in good condition and perform as designed. Quality testing to align with the requirements stipulated by the National dose registry and/or international quality standard for occupational dosimetry service providers.

**Packing (General Condition of Contract Clause No: 9)**

Components (where applicable) must be packaged such that they prevent damage during transportation and storage.

**Delivery and Documentation (General Condition of Contract Clause No: 10)**

The appointed bidder shall notify iThemba LABS to collect dosimeters when these are ready for collection in each wearing period. The appointed bidder shall email electronic copies of dose results (in MS Excel or CSV format) for each wearing period as well as the invoice.

**Payment (General Condition of Contract Clause No: 16)**

Payment terms are within 30 working days of receipt of an invoice issued in each wearing period.

**Prices (General Condition of Contract Clause No: 17)**

The price schedule for dosimetry service performed under the contract shall not vary from the prices quoted by the supplier in his bid with iThemba LABS with the exception of any price adjustments authorized in this section.

1.	<b><u>Exceptions:</u></b> Exceptions to the clause are incidental services, changes in Value Added Tax as gazetted, exchange rates and spare parts.
2.	<b><u>Price Adjustment Rules:</u></b> Price adjustments and their corresponding rules for the managing of price risks on the basis of the iThemba LABS and the appointed bidder sharing the risk equally.  <b><u>Replacement components</u></b> –iThemba LABS will consider price variations at the anniversary of the contract. The contract bidder provides detailed reasons for price variations substantiated by evidence such as manufacturer’s increase letters, verifiable consumer price variations. iThemba LABS enters in negotiation on the submitted price variations. iThemba LABS reserves the right to obtain three price quotes from the market to verify the submitted price variations are within such identified market price ranges.  <b><u>Additional Parts and Components</u></b> – iThemba LABS may require, as determined by future operational requirements, additional dosimeters. iThemba LABS, in such event, will notify the appointed bidder of such requirements. The appointed bidder provides revised pricing detailing reasons for price variations substantiated by evidence such as manufactured country’s inflation rates, technology refresh rate impacts, verifiable consumer price variations, and verified movement in exchange rates. iThemba LABS enters in negotiation on the submitted price quotation and variation reasons. iThemba LABS reserves the right to obtain three price quotes from the market to verify the submitted pricing are within such identified market price ranges.



	<p><u>Exchange prices</u> – Where the supplied requirements are from overseas, the appointed bidder will state the portion and currency payable overseas separating local costs. iThemba LABS will only consider exchange rate variations on the identified foreign price component. The rate variation is the difference between the current exchange rate and the exchange rate ruling at the date of signing the SBD 7. Exchange rates are obtained from ABSA or for the www.xe.com website. iThemba LABS will verify the submitted exchange rate variation and enter into negotiation with the appointed bidder on the agreed variation.</p>
3.	<p><b><u>Ceiling Price Calculation for price competition:</u></b> iThemba LABS provides bidding estimates of quantities to allow for the calculation of a bidding price for the contract that allows an equal comparison basis equitable to all bidders for award selection.</p>
4.	<p><b><u>Commitment to Appointed Services Provider:</u></b> iThemba LABS, through the signed contract, guarantees its procurement of the equipment and service from the appointed party only where the appointed party meets or exceeds the contractual performance levels.</p>
5.	<p><b><u>Contract Price Management in terms of the Contract:</u></b> iThemba LABS issues written purchase orders authorising the work as required in this contract as addendums to the contract. The purchase orders stipulate quantity, work description, delivery date, and the unit price in accordance with this contract. iThemba LABS, when issuing the written purchase order, guarantees that the funding is available for the value of that purchase order.</p>
7.	<p><b><u>Contract Price:</u></b> The cumulative value of all purchase orders issued and paid for is the total value of this signed contract at its expiry/completion date.</p>

**Termination for Default (General Condition of Contract Clause No: 23)**

In the event of the non-performance as per the agreed contract, iThemba LABS will appoint an alternative provider at the cost of the appointed bidder. The defaulting appointed bidder is obliged to settle the damages/additional costs that iThemba LABS has incurred as result of the non-performance of the appointed bidder.

**PERFORMANCE LEVEL (General Condition of Contract Clause No: 22)**

If the appointed service provider fails to meet any performance level:

- a) Both iThemba LABS RPO/ARPO and the appointed service provider shall jointly investigate and report on the root causes of the performance level failure;
- b) Promptly correct the failure and begin meeting the set performance levels;
- c) Advise iThemba LABS as to the extent requested by iThemba LABS of the status of remedial efforts being undertaken with respect to such performance level failure; and
- d) Take preventive measures to prevent the recurrence of the performance level failure.

## EVALUATION PROCESS

A multiple stage process, with sub-stages when required, is followed:

**Administrative stage (One):** (CSD registered/SBD's//Returnable document list/datasheet) Compliance with administrative and evaluation requirements as stated in Part A. All bidders that fail to meet these requirements are disqualified from further evaluation.

**Technical stage (Two):** Compliant bidders will be evaluated based on the technical compliance in Part A. This stage may consist of multiple sub-stages as set out in Part A. All bidders that fail to meet the technical minimum are disqualified from further evaluation.

**Scoring stage (Three):** Points are scored on the basis of Price as indicated on SBD 1 in accordance with the PPPFA.

“EME” means an Exempted Micro Enterprise in terms of a code of good practice on black economic empowerment issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act;

“Market Price” means tests to verify the offered prices are market related to the NRF in allowing the bidder to complete the work without risk of performance failure to the NRF and that the price provides the sustainability to the bidder.

“Functionality” means the ability of a bidder to provide goods or services in accordance with specifications including quality that deliver the set levels of performance functionality as set out in the bid documents.

### **Award and Contract Signing**

The NRF nominates the bidder with the highest combined score for the contract award subject to the bidder having supplied the relevant administrative documentation.

### **Cancellation of the Bid prior to Award**

The NRF cancels the Bid Invitation prior to making an award where

- a. Due to changed circumstances there is no need for the specified procurement in the document, or
- b. No bids meet the minimum required specification, or
