- Research Radiation Biophysics
- The supply of Accelerator-produced Radioactive Isotopes for Nuclear Medicine and Research

## CONTEXT OF THIS PROCUREMENT NEED

iThemba LABS, Nuclear Medicine Department produces Radioactive Material (Radiopharmaceuticals and Radioisotopes) such as  $^{68}\text{Ge}/^{68}\text{Ga}$  Generators,  $^{82}\text{Sr}$  (Rb Metal Targets) and  $^{22}\text{Na}$  Positron Sources and Solutions on a pre-determined production schedule on a weekly or monthly basis. These products produced by iThemba LABS are used in Nuclear Medicine Institutions worldwide for diagnostic nuclear medicine applications and at University Physics Departments performing positron annihilation studies.

The products have a limited half-life (shelf-life), and therefore needs to be freight forwarded to the end-user from the iThemba LABS facility, Cape Town with absolute promptness as per the delivery schedule.

iThemba LABS, Nuclear Medicine Department seeks to appoint a service provider to serve as a Freight Forwarder to transport its Radioactive Material (Radiopharmaceuticals and Radioisotopes) from its facility in Cape Town to its clients (Hospitals/Clinics/Institutions/Universities) worldwide for a period of five (5) years on a pre-determined production schedule. The bidder to have the appropriate Regulatory Licenses in place for the worldwide deliveries.

# PART A – CONTRACT

## DETAILED SPECIFICATIONS

- Freight forwarding services including collect, transport, forward and clear its Radioactive Material (Radiopharmaceuticals and Radioisotopes) such as  $^{68}\text{Ge}/^{68}\text{Ga}$  Generators,  $^{82}\text{Sr}$  (Rb Metal Targets) and  $^{22}\text{Na}$  Positron Sources and Solutions on a pre-determined production schedule on a weekly or monthly basis.
- Destinations will be added, where such need arise.

- **Transportation vehicles for transporting of Radioactive materials**
  - The vehicles for transporting of Radioactive materials must have appropriate radioactive signs as well as radiation tracking monitoring equipment.
  - The vehicle for transportation of Radioactive materials to be used for this contract must annually registered and in possession of verification proof (certificates & pictures).
  - iThemba Labs reserves the right conduct inspection on the vehicles, pre-& post award.
  - Destinations will be added, where such need arise.
- **Documentation and Communication**
  - Quotation from Freight forwarder
  - Airwaybill
  - Documents from South African customs
  - Tracking document (showing tracking information)
- **Risk, Liability and Insurance**
  - Risk in and to the Consignment shall be with bidder while the consignment is in the bidder's possession and shall automatically pass to the receiver upon delivery thereof to the address stated on the applicable delivery document and shall serve as prima facie proof that the Consignment was delivered, and that risk has passed to the Receiver. Should the bidder be unable to effect delivery of the consignment, it shall notify IThemba LABS accordingly and take all reasonable steps to return the consignment. iThemba LABS will remain responsible for the costs of carriage, attempted delivery and return of the Consignment.
  - The bidder shall not be liable for any direct and/or consequential loss and/or damages (of any nature whatsoever) suffered by iThemba LABS, receiver or any third party, including loss of profits, loss of sales, loss of revenue, loss of opportunity and/or loss of contracts, howsoever caused.
  - In addition to the above, iThemba LABS hereby waives any claim of whatever nature which it may have against the bidder beyond the amount recovered by bidder under any risk insurance policy kept by the bidder as contemplated in the SCC11. The bidder will make every effort to ensure that such insurance is in place with a reputable underwriter.

- IThemba LABS has taken responsibility to obtain insurance cover at their own cost in respect of consignments. As such and subject to terms and conditions it has the following in place:
  - Imports/Exports: R5m any one vessel and/or conveyance unless otherwise declared to and accepted by Insurers prior to loss accident or arrival. R10m any one location during transit or as provided, at any one time, unless otherwise declared to and accepted by Insurers prior to loss or accident.
  - Inland Transit R5m any one conveyance

## MANDATORY QUALIFICATION TO EXECUTE THE CONTRACT

### 1. The bidder provides the following as proof of being able to execute the contract to the contract terms:

- 1.1. A proposal outlining how the company will approach the Service Delivery as referenced in the Scope of Work. (Detailed Plan/Standard Operating Procedure) with evidence of it being applied for similar clients.
- 1.2. A Company Profile (Including Company Experience in similar projects for freight forwarding services).
- 1.3. SAHPRA authority to convey radioactive materials. Proof to be submitted (copy of SAHPRA authority) .
- 1.4. Department of Mineral Resources and Energy License to Transport Radioactive materials (Import and Export). Copy of License is required.
- 1.5. Drivers are required to have done Radiation Protection Training on Safe Transport of Radioactive Material. CV or attendance certificate to be submitted.
- 1.6. Drivers are required to have PDP to Transport Dangerous Goods. Certified Copy of Drivers Licence with PDP.
- 1.7. Registration with South African Revenue Service (SARS) for clearing of shipments. Proof must be provided.
- 1.8. To provide three (3) written reference letters from the bidder's referees where the bidder has rendered successful deliveries of >99% (first time on time) for the last 5 years related to Radioactive Consignments worldwide.
- 1.9. A Risk Plan in the event of an accident during transportation of Radiological Consignments to be provided (Risk plan).
- 1.10. To provide certified copies of the certificates and list of the transportation vehicles for transporting of Radioactive materials to be used for this contract.
- 1.11. To provide visible proof (pictures/document) that the transportation vehicles for transporting of Radioactive materials have appropriate radiation warning signs, appropriate UN number, emergency number, first aid kit, trem card, contact person as well as radiation monitoring equipment.
- 1.12. The bidder must provide a CV of a dedicated Key Account Manager that will be assigned to iThemba LABS account as well as after-hours support.
- 1.13. Procurement Invitation (SBD 1), signed and completed.
- 1.14. Bidder's Disclosure (SBD 4), signed and completed.

## Project Management

## Implementation, hand over, and product management

The appointed bidder provides the delivery management as specified in the detailed specification / terms of reference. iThemba LABS will issue purchase orders as a project control tool "for each batch/lot being despatched and will monitor the execution of the delivery schedule until the purchase order requirements are received on site.

## Incidental Services to the subject matter of this contract (General Condition of Contract Clause No: 13)

In the event of requiring such incidental services, it is only valid if confirmed through the issue of a written purchase order that specifies, where applicable, quality, quantity, description, unit price, and delivery date.

## Performance Verification (General Condition of Contract Clause No: 8)

The iThemba LABS appointed project manager verifies the performance of this contract with reference to the required requirements and any other element specified in this contract:

1. The appointed service provider shall serve as a Freight Forwarder to transport its Radioactive Material (Radiopharmaceuticals and Radioisotopes) from its facility in Cape Town to its clients (Hospitals/Clinics/Institutions/Universities) worldwide for a period of five (5) years on a pre-determined production schedule.
2. The appointed bidder will render services as per specifications under this contract.
3. Both parties agree on quantity, unit cost, and total value on the same signed document.

## Contract Due Diligence during the contract period

iThemba LABS has the right to conduct supply chain due diligence. The iThemba LABS Project Team have the right to conduct site visits and inspections at any given time during the contract period.

## Communication (General Condition of Contract Clause No: 31)

The appointed bidder communicates in writing through regular mail, physical delivery, or email. The appointed bidder states the contract number and purchase order number on communication documentation. The contract bidder does not act upon any communication without the contract number or must verify such communication with the iThemba LABS project manager prior to acting upon it.

## Performance Security (General Condition of Contract Clause No: 7)

An acceptable financial performance bond is required where iThemba LABS pays an upfront deposit in excess of R 1 million to the same value as any such upfront deposit. No other performance security is required.

**Packing (General Condition of Contract Clause No: 9)**

Components (where applicable) must be packaged such that they prevent damage during transportation and storage.

**Delivery and Documentation (General Condition of Contract Clause No: 10)**

The radioactive material certification for drivers must be renewed annually as well as the regulatory and licenses of vehicles.

**Payment (General Condition of Contract Clause No: 16)**

Payment terms are within 30 days of receipt of an invoice issued following successful rendering of services and earlier where the invoices are accompanied by signed iThemba LABS delivery validation documents including proof of performance stating acceptance of quantity, acceptance to specification, and unit pricing in agreement with the contract and any purchase orders issued in terms of the contract.

It is in the interests of the appointed bidder to adhere to these to receive prompt payment. Any losses incurred through exchange rate variations or interest charged on late payment will be charged to the appointed bidder where these costs arose from non-adherence to the above.

**Prices (General Condition of Contract Clause No: 17)**

The price schedule for the bid under the contract shall not vary from the prices quoted by the service provider in their bid with iThemba LABS with the exception of any price adjustments authorized in this section.

1.	<b><u>Exceptions:</u></b> Exceptions to the clause are incidental services, changes in Value Added Tax as gazetted, and exchange rates <del>and spare parts</del> .
2.	<b><u>Price Adjustment Rules:</u></b> Price adjustments and their corresponding rules for the managing of price risks on the basis of the iThemba LABS and the appointed bidder sharing the risk equally.  <b><u>Additional Services</u></b> – iThemba LABS may require, as determined by future operational requirements, additional services. iThemba LABS, in such event, will notify the appointed bidder of such requirements. The appointed bidder provides revised pricing detailing reasons for price variations substantiated by evidence such as manufactured country’s inflation rates, technology refresh rate impacts, verifiable consumer price variations, and verified movement in exchange rates. iThemba LABS enters in negotiation on the submitted price quotation and variation reasons. iThemba LABS reserves the right to obtain three price quotes from the market to verify the submitted pricing are within such identified market price ranges.  <b><u>Exchange rate prices</u></b> – Where the supplied requirements are from overseas, the appointed bidder will state the portion and currency payable overseas separating local costs. iThemba LABS will only consider exchange rate variations on the identified foreign price component. The rate variation is the difference between the current exchange rate and the exchange rate ruling at the date of signing the SBD 7.1. Exchange rates are obtained from ABSA or for the www.xe.com website. iThemba LABS will verify the submitted exchange rate variation and enter into negotiation with the appointed bidder on the agreed variation.
3.	<b><u>Ceiling Price Calculation for price competition:</u></b> iThemba LABS provides bidding estimates of quantities

	to allow for the calculation of a bidding price for the contract that allows an equal comparison basis equitable to all bidders for award selection.
4.	<b><u>Commitment to Appointed Services Provider:</u></b> iThemba LABS, through the signed contract, guarantees its procurement of service from the appointed party only where the appointed party meets or exceeds the contractual performance levels.
5.	<b><u>Contract Price Management in terms of the Contract:</u></b> iThemba LABS issues written purchase orders authorising the work as required in this contract as addendums to the contract. The purchase orders stipulate quantity, work description, delivery date, and the unit price in accordance with this contract. iThemba LABS, when issuing the written purchase order, guarantees that the funding is available for the value of that purchase order.
6.	<b><u>Contract Price:</u></b> The cumulative value of all purchase orders issued and paid for is the total value of this signed contract at its expiry/completion date.

**Termination for Default (General Condition of Contract Clause No: 23)**

In the event of the non-performance as per the agreed contract, iThemba LABS will appoint an alternative provider at the cost of the appointed bidder. The defaulting appointed bidder is obliged to settle the damages/additional costs that iThemba LABS has incurred as result of the non-performance of the appointed bidder.

**PERFORMANCE LEVEL (General Condition of Contract Clause No: 22)**

If the appointed bidder fails to meet any performance level:

- a) Both iThemba LABS and the appointed bidder shall jointly investigate and report on the root causes of the performance level failure;
- b) Promptly correct the failure and begin meeting the set performance levels;
- c) Advise iThemba LABS as to the extent requested by iThemba LABS of the status of remedial efforts being undertaken with respect to such performance level failure; and
- d) Take preventive measures to prevent the recurrence of the performance level failure.
- e) In the event of the non-performance as per the agreed contract, iThemba LABS will appoint an alternative provider at the cost of the appointed bidder. The defaulting appointed bidder is obliged to settle the damages/additional costs that iThemba LABS has incurred as result of the non-performance of the appointed bidder.
