#### **DEEP CLEANING AND SANITISING SERVICES**

Deep Cleaning Service is required in all the Ablution Facilities at iThemba LABS Cape Town for Hygiene purposes and to comply with Occupational Health and Safety Act requirements. Deep Cleaning Services entail disinfecting and sanitizing the entire ablution facility and shall be conducted on a Quarterly basis.

The removal and sanitising of Sanitary Towels Waste Bins will also be required. The process is as follows:

- 1) Sanitary Bins will be removed from ablution facilities and taken to a processing room in P-Block
- 2) The liners in the bins will be removed, placed in another bag and secured for disposal by an approved service provider for the waste stream type (iThemba LABS to source service provider)
- 3) Bins will be sanitised and an appropriate liner will be placed in the bin
- 4) Bins will be returned to their designated ablution facilities.

Removal of the Sanitary Towel Waste Bins shall be done every two (2) weeks.
