INTRODUCTION TO THE ITHEMBA LABS BUSINESS UNIT

iThemba LABS (Laboratory for Accelerator-Based Sciences) is a multi-disciplinary research laboratory based at two sites in the Western Cape and Gauteng respectively, providing facilities for:

- Basic and applied nuclear physics research using particle beams
- Research radiation biophysics
- Research in Material and Nano science
- Research in Accelerator Mass Spectrometry
- The supply of accelerator-produced radioactive isotopes for nuclear medicine and research.

CONTEXT OF THIS PROCUREMENT NEED

iThemba LABS, as a national facility of the NRF, provides research platforms for pure and applied research and development in Accelerator-Based Sciences. The key stakeholders of iThemba LABS have a legitimate expectation of state-of-the-art equipment that is well maintained and reliable, as well as efficient service delivery and expert in-house support.

With the near completion and commissioning of the SAIF (South African Isotope Facility) complex at iThemba LABS, there is now a need for a dedicated Helium Leak Detector and Sniffer Leak Detector. This equipment will be used for the locating of vacuum and helium leaks on the SAIF cyclotron, beamlines and target stations.

The reason for new and additional equipment is that the areas in which they are used are generally designated Red Areas, (radiation protection designation). For safety reasons, it is required that any equipment or tools used in the red area, rather stay and designated for red area use only.

To remove such equipment will require it to be decontaminated. This poses a problem for the helium leak detector and helium sniffer, as this equipment contains vacuum pumps that easily draw in radioactive particles into the inner workings of the pumps. Which makes it quite difficult to fully decontaminate the machines.

It is for this reason we will require a helium sniffer and helium leak detector that would be permanently located at SAIF facility and only used in the TC, TN and TS vaults, and on occasion in the Red Area at isotope production.

CONTRACT PERIOD

The contract commences with the once off delivery of the specifies equipment followed by a three-year period for support, maintenance, spares and other incidentals. The contract commences from the last signature on the SBD7.1 contract form.

SERVICE SPECIFICATION

1. The contracted bidder to provide technical support for the Helium Detector, and Sniffer leak detector. This technical support to include the ability to supply service kits, and spares that could be required. Technical support also to include information that done verbally or written.
2. The contracted bidder must provide and keep up-to-date technical documentation including service plans that detail what servicing is required, what intervals, and what work is done for each service.
3. The contracted bidder must manage warranty claims including transport to and from iThemba LABS to the warranty repair site. See General Conditions of Contract 15.
4. The contracted bidder must arrange factory repair by the manufacturer if and when required.
5. The contracted bidder must service or repair the equipment if and when required
6. The contracted bidder must maintain stock and supply spares when needed. See General Conditions of Contract 14.
7. Any incidental services are communicated through written purchase order. See General Conditions of Contract 13.

SPECIAL CONDITIONS OF CONTRACT MANAGEMENT

Special conditions amending specific clauses of the general conditions of contract reference the specific clause in the title The General Conditions forming part of these special conditions and conditions of contract are those stated from page 15 to 28.

Project Management

iThemba LABS

iThemba provides the details of its contract manager to the contracted bidder and recorded as an appendix to this document.

Contracted Bidder

The contract bidder provides the details of its contract manager to the contracted bidder and recorded as an appendix to this document.

Implementation, hand over, and subsequent contract management

iThemba LABS will issue purchase orders as a project control tool for the initial purchase and subsequent requirements. iThemba LABS will monitor the execution of the delivery schedule of each issued purchase order.

Performance Verification (General Condition of Contract Clause No: 8)

The iThemba LABS appointed project manager verifies the performance of this contract with reference to the required requirements and any other element specified in this contract:

Contract Due Diligence during the contract period

iThemba LABS has the right to conduct supply chain due diligence. The iThemba LABS Project Team have the right to conduct site visits and inspections at any given time during the contract period.

Communication (General Condition of Contract Clause No: 31)

The appointed bidder communicates in writing through regular mail, physical delivery, or email. The appointed bidder states the contract number and purchase order number on communication documentation. The contract bidder does not act upon any communication without the contract number or must verify such communication with the iThemba LABS project manager prior to acting upon it.

Packing (General Condition of Contract Clause No: 9)

Components (where applicable) must be packaged such that they prevent damage during transportation and storage.

Payment (General Condition of Contract Clause No: 16)

Payment terms are within 30 days of receipt of an invoice issued following successful delivery. The invoices are accompanied by signed iThemba LABS delivery validation documents including proof of performance stating acceptance of quantity, acceptance to specification, and unit pricing in agreement with the contract and any purchase orders issued in terms of the contract.

It is in the interests of the appointed bidder to adhere to these to receive prompt payment. Any losses incurred through exchange rate variations or interest charged on late payment will be charged to the contracted bidder where these costs arose from non-adherence to the above.

Termination for Default (General Condition of Contract Clause No: 23)

In the event of the non-performance as per the agreed contract, iThemba LABS will appoint an alternative provider at the cost of the appointed bidder. The defaulting contracted bidder is obliged to settle the damages/additional costs that iThemba LABS has incurred as result of the non-performance of the appointed bidder.

PERFORMANCE LEVEL (GENERAL CONDITION OF CONTRACT CLAUSE NO: 22)

Measurement, monitoring, and correction of under-performance

All parties measure delivered performance against these performance levels.

Where poor performance has been identified, both parties will meet and investigate the matter to determine the root cause, the correction plan, and the execution planning thereof.

If the appointed Panel bidders fails to meet any performance level:

- a) Both iThemba LABS and the appointed bidders shall jointly investigate and report on the root causes of the performance level failure;
- b) Promptly correct the failure and begin meeting the set performance levels;
- c) Advise iThemba LABS as to the extent requested by iThemba LABS, of the status of remedial efforts being undertaken with respect to such performance level failure; and
- d) Take preventive measures to prevent the recurrence of the performance level failure.

- 2.2 The bidder has provided details for any claim for preference points.

3. Ethical Requirements

- 3.1. The bidder must confirm that there are no interests with the NRF, has clean business practices, and has determined its bid independently from others as reflected on its submitted SBD 4.

EVALUATION PROCESS
